NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISE SET FORTH IN THIS MOU, THE PARTIES HERE TO AGREE AS FOLLOWS:

Clause-I
CO-OPERATION

1.1 Both the Parties are united by common interest and objectives, and they shall establish channels of communication and co-operation that will promote and advance -

- Joint research projects and publications, including work by undergraduate and post graduate students at the partner institutions;
- Faculty and student exchanges based on reciprocity;
- Reciprocal placement of students and co-ops, when possible;
- Team taught courses, including online courses;
- Visits by faculty, professional staff and students;
- Exchange of information on teaching, learning material and other literature relevant to their educational and research programmes;
- Joint organization of short-term continuing education programmes on topics of mutual interest and to invite each other's faculty to participate therein;
- Joint organization of seminars, conferences, or workshops on topics of mutual interest and to invite each other's faculty to participate therein; and
- Any other joint venture for academic enrichment of both the colleges on prior agreement of the Principals of both the Colleges; within the Institution and its related wings.

1.2 Both the Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.

1.3 First Party and Second Party must respect each other's to intellectual property and the disputes if any, relating to any aspect of academic cooperation, Principals of both the College will jointly resolve the dispute in a spirit of independence, mutual respect, and shared responsibility.

Either Party shall have the right to unilaterally terminate this MOU upon 90 days prior written notice to the other party.
