Clause-I

 - Any other joint venture for academic enrichment of both the colleges on prior agreement of the Principals of both the Colleges;

- 1.2 Both the Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.
- 1.3 First Party and Second Party must respect each other's to intellectual property and the disputes if any, relating to any aspect of academic cooperation, Principals of both the College will jointly resolve the dispute in a spirit of independence, mutual respect, and shared responsibility.


