

D) Both Parties being legal entities in themselves desire to sign this MOU for advancing their mutual interests.



· Faculty and student exchanges based on reciprocity;


- Reciprocal placement of students and co-ops, when possible;

Now onwards both the party may mention the name and **LOGO** of the other in their documents as "**COLLABORATOR**" for purpose as may be required subject to communication by the user to the other party in writing beforehand.

1.8 This **MOU** unless terminated by mutual written agreement will continue for 5 years after the effective date specified in the opening paragraph and can be renewed through mutual interest. Either Party shall have the right to unilaterally terminate this **MOU** upon 90 days prior written notice to the other party.
